

#### San Carlos Apache Tribe – Community We Serve



-Established by executive order on November 9, 1871

- -16,000 enrolled tribal members
- -4 Districts: Bylas, Gilson Wash, Peridot, and 7mile.
- -Northern Graham, Gila, and Pinal Counties.
  -Land base of over 1.8 million acres that encompasses a diverse ecosystem.
- -10th largest Indian Reservation
- -Tribal government is the largest employer.

#### Two 638 Programs – Title I

# Legacy Indian Health Service Hospital in San Carlos was built in the early 1960's

- DHHS:
  - Wellness Center was established in 2003, tribally run out-patient mental health and substance abuse program.
  - Other DHHS include: CHR, Public Health, Tribal EMS, WIC, and Food Distribution
- Hospital:
  - San Carlos Apache Healthcare Corporation July 2015








## **SCAHC 638 History**

- SCAHC Transitioned from Indian Health Service - July 2015
- Facilities Department October 2018



#### **SCAHC Pre – Transition Tasks**

- Feasibility Study
- Ensuring Full Tribal Council Support
  - Tribal Resolution
  - Notice of Intent to 638 to Indian Health Service
  - Vetted by Tribal Attorney General and/or Legal Council
- Setting up strong Negotiation Team
  - Lead by Tribal Attorney General
  - Ensure CEO is included
- Setting up a strong board of Directors
  - Healthcare Background
  - Bachelors Degree as Minimum Qualifications

## Lessons Learned

- Community buy-in
  - Perception was that the "Tribe will run the hospital to the ground", "Tribes going to fail", and "IHS will be back"
- Older 638 programs developed the basic frame work for current 638 hospital.
- Communication barriers between 638 CEO and Service Unit Director
  - Would not allow us to be on campus to address staff concerns
- Strong Negotiation Team
  - AFA funding negotiations
- Change Management and/or Organizational Behavior and Culture
- Board have a business plan and a strategic plan or at least a start-up plan in place
- Ensure Billing and Coding is in place
  - Tribal Health Insurance
  - Medicare/Medicaid
- Strategic Plan and/or Business Plan for Start Up/Transition Phase
